

Software Enterprise License Agreement Integra for Notes & Integra Quick Reports

This license agreement covers the use of the software products called *Integra for Notes* and *Integra Quick Reports* and any upgrades thereto (hereinafter referred to as the *Software Products*) developed and owned by Shireburn Software Ltd. Carefully read this license agreement prior to installing and using the *Software Products*.

If you do not agree with any of the terms and conditions of this license agreement, you have the opportunity to indicate this and halt the installation and use of this product immediately.

1. **Scope:** This Software Enterprise License Agreement covers the usage of the software products known as *Integra for Notes* and *Integra Quick Reports*, or any other product provided by *Licencor* with similar functionality, hereinafter referred to as the *Software Products*.
2. **Parties:** This Software Enterprise License Agreement is an agreement between Shireburn Software Ltd, with registered offices at Carolina Court, Guze Cali Street, Ta' Xbiex, MSD 14, Malta, (herein after referred to as the *Licensor*), and **Client**, it's subsidiaries or associated companies, further known as the *Licensee*.
3. The *Licensor* hereby grants to *Licensee* a perpetual non-transferable and non-exclusive license to use the *Software Products* during the term of this license.
4. **Usage:** The Software Enterprise License granted hereunder is limited in scope to cover an unlimited number of users and/or servers within the Lotus Notes domain(s) stated on the Proof of Entitlement issued by the Licensor on purchase of the *Software Products* or as subsequently amended,
5. **Terms of Usage:** this section of the agreement defines the usage entitlement of the different types of licenses and are applicable based on the license covered by this agreement.
 - a. an **Integra for Notes Designer Edition license** allows the creation of *Integra* profiles and/or the running of these profiles by a determined number of designers within the licensed Lotus domain(s). The software can be installed and used on any server or local machine within the licensed Lotus domain up to the number of licenses purchased. An *Integra for Notes Designer* license is applicable where an entity has purchased one or more designer licenses of *Integra for Notes*.
 - b. an **Integra for Notes End-User Edition license** allows the running of profiles created by a Designer Edition by a limited number of end-users within the Lotus Domino licensed domain(s). The software can be installed and used on any server or local machine within the licensed Lotus domain up to the number of licenses purchased. An *Integra for Notes End-User* license is applicable where an entity has purchased one or more *Integra for Notes End-User* licenses which are limited in their user count.
 - c. an **Integra Quick Reports license** allows creation, saving and running of *Integra Quick Reports* by the number of licensed users across any number of Lotus Domino servers. These Quick Reports can be run on any Lotus Domino server or local workstation within the licensed Lotus Notes domain(s).
6. **Term:** The term of this software license agreement shall commence upon the acceptance or use of the *Software Products* by Licensee or his agent and shall continue in perpetuity until terminated in accordance with this section:
 - a. In the case of an evaluation license, the term shall expire on the date contained within the evaluation license key being used for undertaking the evaluation.
 - b. The Licensee may terminate this Software License Agreement at any time effective immediately upon written notice to Licensor.
 - c. Licensor may terminate this Software License Agreement upon written notice to Licensee if Licensee breaches any of its obligations hereunder. Upon receiving such notice of termination, Licensee shall have sixty (60) days from the date of such notice to cure any alleged breach. Termination pursuant to this section of the license agreement shall be effective as of the sixty first (61st) day following the date of the written notice provided pursuant to this section, unless such breach has been cured to Licensor's satisfaction before such date.
 - d. The Licensee reserves the right to terminate this Software License in the event that the appropriate License Fees have not been paid as agreed.

In all cases, the Licensor shall have no obligation to refund any amounts paid to it under this Software License Agreement. Upon termination of this Software License Agreement, Licensee shall immediately discontinue use of and destroy all copies of the Software Product and any documentation provided therewith, and shall provide Licensor with a confirmation of termination with this section signed by an authorized officer or senior manager of Licensee. Licensor shall have the right to verify the Licensee's compliance with this termination.

7. This license to use the *Software Products* does not include the right to sub-license to any person or entity nor does it grant to Licensee the right to sell, lease, assign or otherwise transfer or dispose of the *Software Products*, in whole or in part.
8. **Intellectual Property:** The *Licensee* acknowledges that the *Licensor* is and remains the sole owner to all titles, rights, and interests in and to the *Software Products* and all subsequent versions thereof including the documentation. This acknowledgement extends to cover without limitation, patent, copyright, trade secret, trademark and all other proprietary rights. Licensee shall not obtain any intellectual property rights in or to the Intellectual Property Rights of the *Software Products* and no access or rights to the source code or equivalent are imparted through this software license agreement.

9. **Explicit Restrictions:** Licensee shall not:
- alter, enhance or otherwise modify the *Software Products* or any upgrade thereto;
 - disassemble, decompile or reverse-engineer the *Software Products* or any upgrade thereto;
 - otherwise take express action to discover the equivalent of the *Software Product* or any upgrade thereto.
 - make copies of the Software or allow copies of the Software to be made by others, unless authorized by this License, except for operational security and backup purposes.
 - disassemble, decompile or "unlock", reverse translate, or in any manner decode the Software for any reason whatsoever;
 - provide or otherwise make available the *Software Products* in any form to any unlicensed person without the written consent of the Licensor;
 - rent, lend or lease the *Software Products*;
 - transfer the *Software Products* to any other person under any circumstances without the written consent of the Licensor;
 - attempt to bypass or circumvent the security procedures applicable to the *Software Products*;
 - take any action that would cause injury to the Licensor's intellectual property rights in the *Software Products* or that would deprive Licensor of the license fees to which it is entitled.
10. **Data Protection:** Licensee authorizes the Licensor to maintain information about the Licensee in terms of the Data Protection Act 2002 (Malta) and to use this information for the purposes of informing the licensee of new products and versions and to identify the Licensee as a user of the *Software Products*. The Licensor acknowledges and extends all the protection and remedies envisaged in this law.
11. This License extends to the Software documentation, whether in electronic, on-line or printed format. The documentation may not be copied, modified or used in any way not contemplated or expressly authorized by this License.
12. **Limited Warranty:** The *Software Products* are subject to a limited warranty. Licensor warrants to Licensee that the physical medium on which the *Software Products* are distributed is free from defects in materials and workmanship under normal use, the Software will perform according to its printed documentation, and to the best of Licensor's knowledge, Licensee's use of this Software according to the printed documentation is not an infringement of any third party's intellectual property rights. The Software has been tested by Licensor for viruses and bugs using standard industry practices on the hardware, software and operating systems for which it is certified and has been found acceptable. The Software will correctly process dates, including leap years. The Software contains no mechanism allowing Licensee information to be retrieved remotely by Licensor and the Software may not be remotely disabled.

This limited warranty lasts for a period of 90 days after delivery. To the extent permitted by law, THE ABOVE-STATED LIMITED WARRANTY REPLACES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, AND LICENSOR DISCLAIMS ALL IMPLIED WARRANTIES INCLUDING ANY IMPLIED WARRANTY OF TITLE, MERCHANTABILITY, NONINFRINGEMENT, OR OF FITNESS FOR A PARTICULAR PURPOSE. No agent of Licensor is authorized to make any other warranties or to modify this limited warranty. Any action for breach of this limited warranty must be commenced within one year of the expiration of the warranty. Because some jurisdictions do not allow any limit on the length of an implied warranty, the above limitation may not apply to this Licensee. If the law does not allow disclaimer of implied warranties, then any implied warranty is limited to 30 days after delivery of the *Software Products* to Licensee. Licensee has specific legal rights pursuant to this warranty and, depending on Licensee's jurisdiction, may have additional rights.

In case of a breach of the Limited Warranty, Licensee's exclusive remedy is as follows: Licensee will return all copies of the Software Products to Licensor, at Licensee's cost, along with proof of purchase. (Licensee can obtain a step-by-step explanation of this procedure, including a return authorization code, by contacting Licensor at Carolina Court, Guze Cali Street, Ta' Xbiex, MSD 14, Malta [sales@shireburn.com]) At Licensor's option, Licensor will either cure the breach and send Licensee a replacement copy of the Software Products, at Licensor's expense, or issue a full refund.

Notwithstanding the foregoing, the licensor shall not be liable to the licensee for any, special, incidental, exemplary, punitive, or consequential damages, connected with or resulting from this license agreement or licensee's use of the Software Products.

Licensee agrees to defend and indemnify Licensor and hold Licensor harmless from all claims, losses, damages, complaints, or expenses to the extent resulting from Licensee's negligent or willful misconduct. Licensor agrees to defend and indemnify Licensee and hold Licensee harmless from all claims, losses, damages, complaints, or expenses to the extent resulting from Licensor's negligence or willful misconduct. In addition and notwithstanding anything else in this Agreement to the contrary, Licensor will defend or settle, at its own expense, any claim or suit against Licensee alleging that the Software infringes any United States patent or copyright. Licensor will also pay all damages and costs that by final judgment may be assessed against Licensee due to such infringement. The maximum limit of the licensor's liability in all cases shall not exceed a cumulative amount of totaling the value of the license paid by the licensee.

If the *Software Products* become the subject of an infringement suit, Licensor will, at its option:

- procure for Licensee the right to continue using the Software;
 - replace or modify the Software to provide Licensee with a non-infringing product that is functionally equivalent in all material respects; or
 - refund the purchase price or one-time software license fee.
13. The Licensee and/or his agent shall supervise and control the use of the Software in accordance with the terms of this License and shall ensure that his employees, subcontractors or agents who have authorized access to the Software are made aware of the terms of this License and comply therewith. You shall maintain safe custody of the Software.
14. The Licensee hereby grants the Licensor or his agent the right to enter his premises at a mutually agreed time, upon reasonable notice and after mutual agreement upon confidentiality and other restrictions, and to operate any computers at your premises but only to the extent necessary in order to verify compliance with the terms and conditions of the *Software License Agreement*.

15. **Notices** - all notices or other communications required or permitted hereunder shall be in writing and shall be delivered either by fax, by certified/registered air mail or sent by courier and shall be deemed given
 - a. if by fax on the date of receipt of the fax
 - b. if by registered mail or courier upon actual receipt,
16. **Confidentiality:** both parties to this agreement agree to maintain confidential all information reasonably deemed to be commercially sensitive or confidential to either party which is acquired through the performance of this software license agreement and/or the use of the software products.
17. **Governing Law:** This Software License Agreement is governed by the law of Malta applicable to contracts. The Licensor and the Licensee agree that any dispute, controversy or claim arising out of or relating to this contract, or the breach, termination or invalidity thereof, shall be settled by the courts of Malta.
18. **Entire Agreement:** This Software Enterprise License Agreement is the entire and exclusive agreement between Licensor and Licensee regarding the *Software Products*. This License Agreement replaces and supersedes all prior negotiations, dealings, and agreements between Licensor and Licensee regarding this Software.
